ORDER:

In continuation of the orders issued in the reference 6th read above, Government hereby order the revision of rates of Dearness Relief at the rates indicated below from **01.07.2007** in respect of those who retired drawing A.P. Revised Pay Scales, 1993 and whose pension has not been consolidated.

2. Government also hereby order the revision of rates of Dearness Relief at the rates indicated below from **01.07.2007** to the Pensioners who retired while drawing A.P. Revised UGC Pay Scales, 1986 and whose pension has not been consolidated.

3. Government also hereby order the revision of rates of Dearness Relief with effect from **01.07.2007** as follows to the Pensioners who retired from A.P. Higher Judicial Services and A.P. State Judicial Service after 1.7.1996 and continue to draw pension based on the Revised Pay Scales 1993:

| Basic Pension above Rs.4,910/- p.m. | 54% of basic pension/ family pension subject to minimum of Rs.3094/- p.m. |

4. The procedural instructions issued in the G.O.8th read above revising the rates of Dearness Relief from **1st July, 2007** shall be applicable in the above cases also.

5. The arrears of the revised Dearness Relief to Pensioners from 1.7.2007 to 31.1.2008 shall be paid along with the pension of February 2008 payable in March 2008.
